Expression of interest for appointment of statutory Auditor of AIPSSPB


Request for Proposal (RFP) for appointment of Chartered Accountant firm for Statutory Audit & income tax return filing work for the FY 2019-20 onwards of 'All India Public Sector Sports Promotion Board (AIPSSPB)'. AIPSSPB is registered as a Trust under Cooperative Societies Act with an objective to promote, aid, assist and organise sports, all kind of indoor and outdoor games, in public sector undertakings with a view to promote health, welfare & recreation of their employees. The engagement of CA firm would be initially for a period of five years.

The Chartered Accountant firms intending to bid for the aforesaid assignments should comply the following qualifying criteria & conditions:-

1. The CA firm should be registered with the GST Authority and provide a copy of valid GST Registration certification along with price quote.
2. The firm should submit a valid Certificate of Practice from ICAI along with quote.
3. The Chartered Accountant firm should have its office at Delhi & NCR.
4. The CA firm should not be disqualified for audit or any other assignment by ICAI / other regulatory authorities during the last 10 year.
5. The CA firm should not be related to governing member of AIPSSPB. An undertaking in this regard that CA firm is not a 'related party of any governing council members of AIPSSPB', needs to be submitted along with price quote.
6. The price quote for 'Annual Audit fee' should be quoted on lump sum basis for financial year 2019-20 (All-inclusive quotes for fees, local conveyance, out of pocket expenses and any other incidental expenses and present GST of 18%). The lump sum quoted price inclusive of all taxes and duties shall be considered for evaluation for the year.
7. Auditors have to make their own arrangements for travel and no out of pocket expenses will be paid.
8. The Auditor should submit bill for audit fees after audit of the AIPSSPB and submission of filing of Income tax return.
9. Audit fee will be paid within 30 days after submission of complete Bill.
10. In order to complete the audit on schedule, Auditor should be equipped with sufficient team size. However, depending on the quantum and scope of the work Auditor may also plan and deploy additional team for carrying out the audit, if required.
11. AIPSSPB keeps the right to extend/modify the time schedule of Audit, if needed, in consultation with the Auditor.
